



## VENDOR LETTER OF DECLARATION ("VL0D")

### 1. PLEDGES AND UNDERTAKES THAT:

a. We have read and understood, and will comply with:

- (i) the attached **Vendor Code of Business Conduct ("VCOBC")**;  
The VCOBC outlines the standards of behaviour required from the Vendor relating to:
  - (a) Labour & Human Rights;
  - (b) Environment, Safety & Health; and
  - (c) Ethics & Management Practices.
- (ii) **all applicable laws and regulations relating to anti-bribery, fraud and corruption; and**
- (iii) the following **anti-corruption principles**:
  - (a) Committing to promote values of integrity, transparency, accountability and good corporate governance;
  - (b) Strengthening internal systems that support corruption prevention;
  - (c) Fighting any form of corrupt practice; and
  - (d) Supporting corruption prevention initiatives by the Government and the local authorities;to the best of our knowledge (collectively, "The Requirements").

b. We will ensure our subsidiaries, affiliates and all other parties that we appoint to conduct work for the Sime Darby Berhad also comply with The Requirements.

c. We have not been convicted nor are we the subject of any investigation, inquiry or enforcement proceedings by the relevant authorities of any actual or suspected breach to The Requirements and will report any actual or suspected breach to The Requirements as soon as reasonably practicable and to the extent permitted by law, to the Sime Darby Berhad.

### 2. AGREES THAT:

a. In the event that we are in breach of any of the above sections, the Sime Darby Berhad may immediately revoke the contract award, or terminate the contract for the Business Transaction(s)\* without any liability whatsoever on the part of the Sime Darby Berhad to

the Vendor. This is without prejudice to any other rights or remedies that the Sime Darby Berhad may have or any other appropriate action which the Sime Darby Berhad may seek under the terms of the applicable tender/contract or applicable laws and regulations.

- b. Should any person attempt to solicit any bribe or advantage (whether financial or otherwise) from the Vendor or any other person connected to the Vendor either as an inducement or incentive to be selected or as a reward, gift or bonus for being selected in the Business Transaction(s)\*, or where the Vendor has reasonable grounds to suspect any breach of the obligations in this VLOD or the VCOBC, the Vendor will report such act to the Sime Darby Berhad as soon as reasonably practicable.
