#### MODE OF MEETING

The Company will continue to leverage on technology to facilitate communication and engagement with shareholders by conducting the Extraordinary General Meeting ("EGM") on a virtual basis through live streaming and online remote voting via Remote Participation and Voting ("RPV") facilities which are available on Tricor Investor & Issuing House Services Sdn Bhd's ("Tricor") TIIH Online website at <a href="https://tiih.online">https://tiih.online</a>.

The broadcast venue of the EGM is strictly for the purpose of complying with Section 327(2) of the Companies Act 2016 which requires the Chairman of the Meeting to be present at the main venue of the meeting. Shareholder(s) or proxy(ies) or authorised representative(s) or attorney(s) WILL NOT BE ALLOWED to attend the EGM in person at the broadcast venue on the day of the meeting.

## **ENTITLEMENT TO PARTICIPATE AND VOTE**

A shareholder will not be allowed to participate at the meeting if his/her proxy(ies) has/have been registered to participate in the meeting.

- 2. Shareholders or proxy(ies) or corporate representative(s) or attorney(s) may proceed to vote on the resolution at any time from the start of the EGM at 12.30 p.m. on **Thursday, 16 November 2023** until the end of the voting session which will be announced by the Chairman of the meeting. - 3. Upon completion of the voting session for the EGM, the Scrutineers will verify the poll results followed by the Chairman's declaration on whether the resolution is duly passed.
