MODE OF MEETING

1. The Company will continue to leverage on technology to facilitate communication and engagement with shareholders by conducting its 17th Annual General Meeting ("AGM") on a virtual basis through live streaming and online remote voting via Remote Participation and Voting ("RPV") facilities which are available on Tricor Investor & Issuing House Services Sdn Bhd's ("Tricor") TIIH Online website at https://tiih.online.

The broadcast venue of the 17th AGM is strictly for the purpose of complying with Section 327(2) of the Companies Act 2016 which requires the Chairman of the Meeting to be present at the main venue of the meeting. Shareholder(s) or proxy(ies) or authorised representative(s) or attorney(s) WILL NOT BE ALLOWED to attend the 17th AGM in person at the broadcast venue on the day of the meeting.

RPV FACILITIES

ENTITLEMENT TO PARTICIPATE AND VOTE

Shareholders or proxy(ies) or corporate representative(s) or attorney(s) may proceed to vote on the resolutions at any time from 10.00 a.m. on **Thursday, 16 November 2023** until the end of the voting session which will be announced by the Chairman of the meeting. - 3. Upon completion of the voting session for the 17th AGM, the Scrutineers will verify the poll results followed by the Chairman's declaration on whether the resolutions are duly passed.
